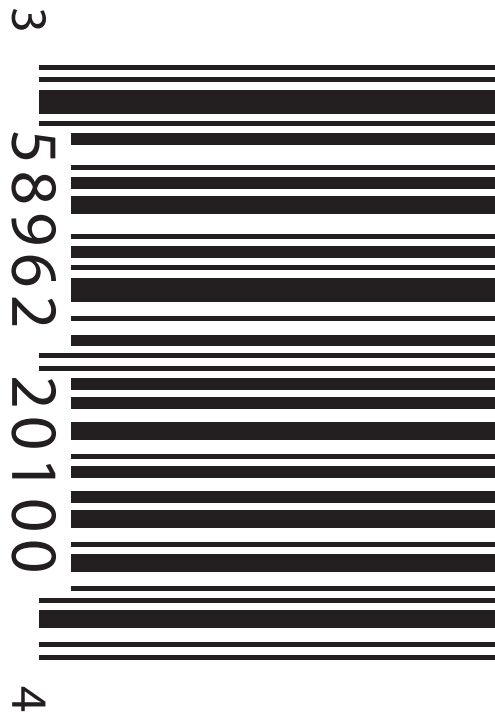

DIRECTIONS FOR USE: To repel mosquitoes and ticks, hold nozzle 6-8 inches from skin and spray evenly on all exposed, dry skin. For best results, spread evenly with hand to moisten skin. **Application to face (Adults):** Do not spray directly on or near face. Instead, spray in palm of hand and spread on face and neck. **Do not apply to face or hands of young children.** Wash hands thoroughly with soap and water after applying. For maximum protection, re-apply every 3 hours or as needed. Do not use as a space spray. **STORAGE & DISPOSAL:** Storage: Store in a cool dry place. Keep away from heat and flame.
